Letter from the President

As we enter the New Year the Board's focus will be to make or beat the 2006 budget by year's end. We were deliberate in our decision not to raise the assessment fees this year. We felt every family in our community needed to keep a little more cash in their pockets to balance the rising cost of gas, groceries and utilities. To that end, we will employ the budget strategies we have already shared with you and continue to gather further input from the community.

Along with needing to make wise financial decisions an equally important piece of work for 2006 is underway right now. At our Shed and Play Structure discussion on December 13, 2005, approximately 30 homeowners brainstormed strategies and solutions in support of changing the current Declaration of covenants, conditions and restrictions. The group unanimously agreed to work toward amending the declaration as it relates to sheds and play structures and have formed a work group to gain community wide support. (See the Dear Neighbor letter)

To amend our declaration we will need 2/3 support of the homeowners or 388 "yes" votes. As the individuals listed below begin to walk around the neighborhood, please give them your time and attention. If you would like to join the team please let any one of the members know of your interest. We would welcome your participation.

Dear Neighbor,

We are writing you to tell you about an important initiative that is underway. As a result of the Shed and Play Structure Discussion on December 13th those that attended agreed that two things need to happen.

- 1. Our current Declarations (deed restrictions) limiting sheds to 8 feet needs to be changed to (not to exceed) 10 feet.
- 2. Our current Declarations (deed restrictions) limiting play structure to 8 feet needs to be changed to (not to exceed) 12 feet.

All who were present unanimously agreed that our current Declarations are outdated and no longer work for our community. In addition, the Board expressed full support of the proposed change.

Beginning this month we will take our recommendations to you, our neighbors, to gain further support. A special meeting of the Homeowners Association will be held on February 28th at St. Max Kolbe from 7-9 pm to vote on the matter.

We will need 388 "yes" votes to support the recommended change to the Willow Pointe Declarations of Covenants, Conditions and Restrictions. We hope that you will join us with your support as well. Sincerely

- 1. The Committee formulated a recommendation to retain Sweetwater Pools for our pool services in 2006. Although Sweetwater has proposed a fee increase of 3% we feel their services have been acceptable and their willingness to work with us outstanding. The recommendation was forwarded to the Board in January.
- 2. The group reviewed information on *Smart-Line* which is an automated, on-site water management system. There are many advantages to this system including a strong potential for costs savings. Further study and review of the product and a request for a cost estimate will come next month.
- 3. We continue to analyze the pool utilization numbers. We have looked at data over a two year period. As we move forward to formulate a recommendation to the Board our goals will include 1) a strong interest to decrease our cost and 2) a desire to minimize the impact on our neighbors. We welcome your comments or if you would like more information. please contact any of our committee members or Judith Schwartz at 832-237-4992 or judithschwartz@sbcglobal. net.
- 4. Formulating a plan to improve the appearance of the Jones Road entrance continues. We would also welcome your comments in this area. The following are cost estimates for potential solutions to the existing "wire".
- A wrought-iron fence slightly taller than the existing brick cubes = \$4,500
- One tree (Bradford pears) planted between the brick cubes = \$5,800
- Wax myrtles planted between the brick cubes = \$2,835
- Red Tip Photinia planted between the brick cubes (these will form a screen in about two years) = \$3,255

As we consider the cost of any improvement we are keeping in mind the long term cost of scrub/tree maintenance and the potential for replacement as well as the cost of maintaining the wrought-iron fence.

Next steps will be to evaluate the degree to which the existing irrigation system will accommodate plantings in the proposed locations.

The Landscape/Pool Committee meets the first Monday of every month at 7 pm at 10506 Elm Knoll Court. We would welcome new membership.

To eliminate the redundancy and reduce our expenses by \$580 a year, the Landscape/Pool Committee made a recommendation to the Board to eliminate the pool room phone. The Board approved the recommendation at the December meeting.

If you or your children need to call home while at the pool be sure to have the correct change tucked in a pocket.

Deed Restriction Topic of the Month

Garbage Cans and Other Trash

Be a good neighbor and store your garbage cans/bags inside of your garage or in your backyard. This applies to other trash stored in the front or on the sides of your home. Not only are these a violation but they take away from the overall good appearance of our neighborhood.

Covenant Article X Section 4

"No trash, rubbish, garbage, manure or debris of any kind shall be kept or allowed to remain on any Lot. The Owner of each Lot shall remove such prohibited matter from his Lot at regular intervals at his expense, and prior to such removal all such prohibited matter shall be place in a sanitary refuse containers with tight fitting lids in an area adequately screened by planting or fencing so as not to be seen from neighboring Lots or public or private streets."

Ms Green Thumb

This is the time of year that most outdoor activities are limited to hanging up or taking down Christmas lights and lawn ornaments. We are generally lounging around the house, glued to the television watching all the bowl games, NASCAR racing, and of course, Stars on Ice. Some are even lucky enough to nap all winter!

While all of this is going on we have long forgotten about our lawn . . . especially when it is brown from the erratic temperatures we have experienced this year. Probably what you don't know is that the grass growth may have slowed down but the roots remain active for a couple of weeks after the top growth stops (these are energy reserves that are stored for the following spring).

It's important to remember that your lawn will only respond in accordance with the level of care and attention you give it. The most important thing you can do for your lawn is to provide it with proper nutrition. A well-fed, healthy lawn has a better root system to combat heat, cold, drought, mowing, foot traffic and other stresses. You should mow and rake your lawn at least every three to four weeks between November and March. This will stimulate the roots and establish new growth in the existing grass and will also allow it to green up earlier in the spring. You may also want to fill in bare spots now that don't naturally mend themselves.

When to Fertilize (Late February – March)

Apply a non-slow release 15-5-10 fertilizer for a quick early greenup. If you apply a herbicide to your lawn three times a year, you

will never need to use a week-and-feed during this time. However, given the possibility that you got caught up in the Saturday afternoon performances of Stars on Ice and you forgot about your depraved lawn, you can use a spot weed-and-feed treatment for turf-only landscape or landscape that has been established for many years. You should also be mindful of the fact that most weed-and-feeds contain Atrizine, a product that will burn the roots of young trees and shrubs, so you should strive to keep these products away from these plants/trees as much as possible.

How to Apply Fertilizer

Don't know exactly how to apply fertilizer to your lawn? Here are some useful tips.

- With a good quality spreader and the proper fertilizer, start by making two header strips at each end of your yard.
- Walk at a steady pace, for even, ideal distribution throughout
- Go back and forth between the ends, shutting the spreader off when you reach the header strips. When starting back, put the spreader in motion before opening it in the header strip.

Watering

Watering your lawn is *vital* in the winter months when have weeks without rain. As a general rule, grass should have 1-2 inches of water per week, including any rainfall. Your lawn is telling you it needs water when it looks dull and droopy and when you walk across it, you leave footprints. It is best to water early in the morning for two reasons: one, there is less evaporation and two, it gives the lawn a chance to dry out before nightfall, which helps prevent diseases.

Finally, St. Augustine responds dramatically to being properly fed. Get yourself in the habit now of fertilizing your lawn four times a year on a regular basis, and you will undoubtedly have a bodacious lawn that come spring, will make your neighbors green with envy.

Ms. Green Thumb will be a regular feature in future newsletters. Stay tuned . . . next month she'll tell us how to choose fertilizer and when to fertilize for optimal results.

Garbage Collection

- 1. Twice weekly collection of household garbage occurs on Monday and Thursday.
- 2. Please place waste on the curb away from parked cars, the mailbox, landscape or other impediments.
- 3. All brush; tree trimmings, and other wood products <u>must be tied</u>, <u>bundled and placed at the curb</u>. Bundles should not exceed 4 feet in length or 50 pounds in weight. Tree or shrub limbs should not be more than 3 inches in diameter.
- 4. Heavy trash (heavy hauling) is collected curbside on the third Thursday of every month. Heavy trash consists of items such as refrigerators, stoves, hot water heater, furniture, moving boxes. Etc. All boxes must be flattened. An appliance technician stating the Freon has been removed must tag all items containing a refrigerant/Freon including air conditioners.

Politics 101

After Christmas this year comes the political season. To participate you have to be registered to vote at least 30 days before the election. The first election in 2006 will be the primary election, Tuesday, March 7th. By now you should have received your new voter's registration card. Willow Pointe is in two voting precincts. The dividing line is the drainage ditch just west of the swimming pool. The eastern half is in precinct 759. The western half is in precinct 671.

On March 7^{th} you will have the opportunity to participate in what is called the "grass roots politics". Voters in the different party primary elections determine the candidates who will represent their party in the general election, November 7^{th} . The election this year is also known as the Governor's election.

Everyone who is eligible should register and vote. Take the time to learn about the candidates and issues. Pay attention to where the money comes from and who is endorsing the candidates and issues.

Many citizens do not want to participate in the primary election because they do not want to be known as a Democrat or Republican. They believe in being "Independent". These people are letting other voters decide for them who the candidates in November will be. Also, sometimes there are consensus issues on the primary ballot. The political parties want to learn the opinion of voters on important issues. This year resolve to not be a fence sitter – register to vote.

After the election on March 7th everyone who voted that day or voted early can return to the voting place for their Party's Precinct Convention which starts at 7:15 pm. The Convention will adjourn if voting is still going on.

The Precinct Convention is the first step in another phase of the election process. The participants in a Precinct Convention will:

(1) Elect convention officers. (2) Introduce, discuss and vote on resolutions concerning a wide range of topics. (3) Elect delegates in the 7th Senatorial District Convention.

If you have an issue and want to find out if your fellow voters feel the same, write a resolution to introduce at the Precinct Convention.

If a resolution is passed at the Precinct Convention it is sent with the convention minutes to the Senatorial District Convention. The Senate District Conventions are held on March 25th. The location of the Republican Convention has not been decided at this time. The Democratic Convention will be held at the West Loop Center Houston Community College, 5601 W. Loop S.

All resolutions passed at the Precinct Convention will be forwarded to the Resolutions Committee. This Committee will pas, vote down, amend or combine resolutions. A report to the convention is drafted and voted on by the convention delegates. Local dignitaries and elected representatives will make appearances at this convention. Convention officers will be elected. The Republican State Convention will be held June 2 and $3^{\rm rd}$ in San Antonio. The Democratic State Convention will be held June $8-10^{\rm th}$ in Ft. Worth.

The delegates to the State Convention will elect officers, vote on resolutions and adopt a party platform. The platform explains the parties' position on most important issues. More of us need to study these platforms. To participate in any of this Right, we as citizens of the USA have, you need to register to vote. 1 large yellow onion, chopped

1 8oz can of chopped tomatoes or 1 can of Ro-tel
