CALL TO ORDER: With quorum duly established, President Howard called the meeting to order at 7:00 p.m.

OPEN FORUM: Corporal Blackledge was present to discuss various community concerns. He discussed coverage areas, recent crime and attendance at community events. He agreed to attend an open meeting for the community on January 10, 2007 to discuss resident concerns and answer questions.

Discussion held to appoint Mrs. Tina Bunn to fulfill the vacant position on the Board of Directors. Director Whitley motioned to appoint Tina Bunn as Secretary, thus relinquishing the position.

A MOTION WAS PASSED to appoint Ms. Bunn to complete Amy Merrill's term and to serve as Secretary; (Motion – Whitley, 2nd – Lilienthal, Unanimous).

MEETING MINUTES: Consideration was given to the November 13, 2006 Board of Directors Meeting Minutes.

A MOTION WAS PASSED to approve the November 13, 2006 Meeting Minutes as written with amendment as noted above; (Motion – Howard, 2nd – Whitley, Unanimous).

FINANCIAL REPORTS: Treasurer Lilienthal discussed the financials and the discrepancies and difficulty in reconciling the Sterling account. Ms. Jensen explained that PMG's accounting department had recently obtained the statements and will reconcile the accounts. The board also noted they would like the Sterling account closed once reconciled and all auto-draft payments have been moved. It was noted the loan was paid in full.

Discussion held regarding on-site personnel. Mr. Lilienthal noted he had a candidate to replace Angie Ramirez and would contact her to confirm. Discussion held regarding salary paid as well as job description. The duty was clarified as cleaning, trash placement for pick-up, changing of the marquee sign, handling of meeting room





rentals and any other community items requested by the Board. A salary was set and person must contact PMG as they will need to be established as a PMG employee for payroll processing.

OLD BUSINESS: Facility Access – Ms. Jensen advised bids were pending. The Board had elected to obtain costs to install a system on the courtyard gate at the Mills Park location and to the tennis courts at Cypresswood. Ms. Jensen will contact the vendors to revise their bids.

Building Repairs – Ms. Jensen is submitting requests to alternate contractors as she has not received original submissions.

Pool Hours – Discussion held to modify pool hours based on Cy-Fair schedule. Ms. Jensen will review when 2007 schedule is posted.

NEW BUSINESS: PMG had received a complaint regarding the height of the toddler swing-seats. President Howard will review.

EXECUTIVE SESSION: Attorney Status – Ms. Jensen questioned the board if they would prefer a summary of the most recent updates as the report was lengthy and would produce high copy costs. The Board indicated that would be preferred; however, they requested more detail on payment plans, bankruptcies and balances. Ms. Jensen will prepare a spreadsheet to condense the information requested.

Delinquency – The Board reviewed the delinquency report in conjunction with the attorney status report.

The Board requested a meeting with the Association attorney to discuss procedures, foreclosures and liens. The Board also requested to know if they may use a collection agency. Ms. Jensen will obtain opinion from the attorney.

Discussion held regarding Association purchases made by board members and requested PMG to determine if a credit/debit card may be obtained.

Consideration given to the deed restriction report; no action necessary at this time.

The Board agreed to allow the swim-team to install a flag pole at the recreation center; Ms. Jensen will obtain cost estimate.

Director Whitley requested a \$1500.00 budget for the events committee. Ms. Jensen advised several surveys had been received. The committee will focus on an Easter and Christmas event for the community. The Board approved a budget of \$1,500.00. President Howard also discussed obtaining community involvement to adopt a unit stationed in Iraq. Further consideration will be given.

President Howard reported he had the computer system operational and is completing what needs to be done for camera operation and activation of access cards. Determination is being made if the programming and monitoring may be done at PMG's office.

It was noted the Green Mountain contact would be expiring; Ms. Jensen will obtain renewal quotes and alternative quotes.

Adjournment: With no further business to discuss, the executive session adjourned at 9:50 p.m.



Dental Tip of the Month.

Dear Friends,

People are living longer than ever before. People are keeping their teeth longer. There are fewer and fewer patients with full dentures. As a result more older individuals are visiting our offices for their dental care. Some of the more common areas of concerns among older population are root caries, where cavity is occurring on the root of the tooth. To prevent root caries, effort should be made to brush the gum line really well. Another problem, xerostomia, which is another word for dry mouth, is prevalent in this population mainly due to many medicines they are on. The solution for that is frequent professional cleanings. There are also artificial saliva producers that you can ask your dentist about.

Third problem I see is gum disease, or periodontal disease. This can be due to buildup of plaque and calculus, thus getting inflamed gums and bone loss. Gum disease can also occur due to shifting of the teeth, thus changing the bite. As a result of aberrant forces, can have bone loss that stabilize teeth.

We always try to be cognizant of patient's medical conditions and take that into account. We also understand that many patients have hearing loss and vision loss, thus we take our time and are very patient in tending to your needs.

Use Only Water In Sippy Cups Or Increase Cavity Risk

AAPD Highlights Importance of Proper Use of Toddler Drinking Device

(NAPSA)-Most parents are well aware of the importance of taking care of their children's teeth, so it comes as a shock when they learn their toddlers have cavities during a checkup.

Tooth decay among young children is on the rise-and many experts believe that sippy cups containing sugary beverages are responsible.

The Misuse of Sippy Cups

Because sippy cups prevent spills, they're often used by children for long periods of time over months and years-rather than as a transitional drinking device, a purpose for which they were intended. "Sippy cups were created to help children transition from a bottle to drinking from a regular cup, but they're too often used for convenience," says American Academy of Pediatric Dentistry (AAPD) President Philip H. Hunke, D.D.S., M.S.D. "When kids sip for extended periods on sugared beverages, they're exposed to a higher risk of decay. Sippy cups should only contain water unless it's mealtime."

In fact, a report from the Centers for Disease Control and Prevention (CDC) comparing the dental health of Americans in 1988-1994 and 1999-2002 found that while cavities decreased among older children, cavities in two- to five-year-olds actually increased 15.2 percent.

A Child's First Visit

Hunke views the misuse of sippy cups as just the symptom of a larger issue-the fact that many parents wait too long before taking their children to the dentist for the first time. The AAPD recommends that a child's first dental visit occur shortly after the first tooth erupts and no later than the child's first birthday. But according to the 2005 National Survey of Children's Health (NSCH), only 10 percent of 1-year-olds and 23.8 percent of 2-year-olds had been taken for a preventive dental care visit in the past year.

At the first visit, the pediatric dentist provides information about proper sippy cup use as part of the presentation of a complete program of preventive home care. The dentist also checks the child's teeth to make sure they're developing properly.

"Studies show that children with poor oral health perform worse in school and have less success later in life," says Hunke. "Establishing the right oral care habits early helps get kids headed on the path to a lifetime of good oral health."


