## Letter from the Co-President

Dear Friends,

I have a degree of disappointment as I draft this, my last article for our newsletter. I am reminded of a billboard on I-20 just outside of Stanton, Texas. For those of you that have not driven west, Stanton is a smaller community 30 miles or so east of Midland. I believe the sentiment on the billboard is a good analogy for our neighborhood. Simply the billboard reads something like:

“Welcome to Stanton... Home to 1200 happy citizens and... to a FEW old soreheads.”

Our neighborhood is the welcoming community of somewhere near a 1,000 people. You are the heart and soul of Woodland Hills and make it a neighborhood envied in the community. Candidly it is people like you that convinced my wife and I to make Woodland Hills our home several years ago.

Unfortunately, we do have some neighbors who simply do not live up to the standards set by the majority of our residents. Regrettably, one of my last acts, as co-president has been to authorize the filing of a lawsuit against neighbors who, for whatever reason and after fair warning, do not abide by our covenants and deed restrictions. I do admit to a degree of frustration and lack of understanding why anyone takes the position:

- They are free to perpetually park on the street, even though they have been warned and fined for doing so;
- They need not abide by ACC restriction when remodeling the exterior of their home;
- Regardless of whether they are a mandatory association member, they need not timely tender neighborhood association dues (in some cases bouncing checks without explanation or effort to cure); and
- Racing vehicles up and down our residential streets.

I have probably had more complaints during my tenure as co-president about vehicles parked on the street of one of the southern most avenues in our neighborhood. On one occasion within the last two weeks, a board member drove down the street in question to discover not 1, not 2 but 3 homes apparently in violation of the anti-parking restriction.

Likewise, I do not understand why anyone who moves into the neighborhood without understanding the architectural controls process. It has been said many times, but bears repeating, the ACC is intended to improve and/or maintain “ALL” our homes.

With respect to dues, I simply do not have much time for those “sore heads” who feel they need not timely tender payments or who are not required to pay, electing to absorb the benefits of those that do pay. For those that do not timely tender payment and have a good reason, the board has a process to abate fees if circumstances warrant it. After all we strive to be good neighbors. However, failing to pay, especially if the failure is reoccurring is simply WRONG. This attitude does not belong in our neighborhood. Concerning neighbors who are not required to tender payment of dues and elect not to tender, my question is what do you feel like when someone reaps the benefits of your work? The 20+ year old arguments are no longer valid.

I know I have addressed this before, but the relative propensity to take vehicles modified for racing and racing up and down our neighborhood streets is a safety concern as well as inconsiderate. All it will take is one small child crossing the street without looking is an accident waiting to happen. Not mention the lack of consideration for all the neighbors who suffer from the noise pollution. There are places and times for races. Please take your sport to the appropriate venue.

Turning my attention to the good citizens of Woodland Hills, I thank you for your friendliness, support and contributions over the past three years. I hope to count myself amount number in future years. Special thanks to Darlene, Rod, Delynn, Gloria, Richard, Malinda, Sid, Terrie, John and most of all to Carey. I wish the best of all things to the incoming board. I hope you will have a tremendous run.

## Letter from the Co-President

How quickly another year has passed. With the annual meeting approaching, I pause to reflect on the past 4 years serving on the WHHA board. This has been a rewarding experience that allowed me to establish relationships that otherwise may not have been possible. I appreciate the opportunity to serve as both Treasurer and Co-President.

As board members complete their term it affords other residents the opportunity to do their part. Currently, the board has a couple of positions that need a volunteer for the 3-year term. Each position is vital to the continuity of high standards in the neighborhood. If you have not had the opportunity to serve on the board or have not done so in a while, now is an excellent opportunity to become involved in the process.

The most important issue facing the board today is erosion in the park, specifically the creek. During initial development of the Woodland Hills, the decision was made by the developer to leave the park in a "natural state" for aesthetic purposes. The alternative was to channel the creek, making it straight and possibly having a concrete bottom. While the park truly adds beauty to the neighborhood, over the years, development upstream has increased both the rate of flow and volume of water through the creek. The neighborhood is now confronted with the issue of how to deal with the issue. If you have been in the park, you may have noticed how the channel is getting larger and is now encroaching upon trees that lined the waterway. In the short term, the board will need to decide a course and engage a long-term course of action.

Your next question is money. Over the course of past cash flow cycles, the board has made reserves and saved funds in anticipation of costs related to the project. While possible, an assessment is not probable.

I especially want to thank David Ebert for his tireless work over the past year. While we shared the title of Co-President, David carried the ball for the neighborhood and made my job easy. His work and background have been an asset to the community.

We have several board members who will be returning and have served our neighborhood beyond their call of duty. One board member that I feel doesn't get enough "pats on the back" is Darlene Page. The flowers, lawn maintenance and general repairs to common areas are taken care of seamlessly by Darlene. She even talks to the water pumps in July coaxing them to keep the front pond up to the proper level (O.K., maybe a stretch, let the legend grow). Darlene, thanks for all you do this neighborhood. Let me know when you're ready for me to take care of the nutria.

## Keep Texas Beautiful

KEEP TEXAS BEAUTIFUL has recognized Colleyville as a "Gold Star Affiliate" as a result of the community-implemented plans to prevent litter, minimize solid waste, beautify public areas and educate citizens. The "Keep Colleyville Beautiful" program has certain requirements necessary to maintain our affiliate status. One of the optional activities is having a residential area designated as a "Model Neighborhood". Woodland Hills is striving to get that recognition. This recognition necessitates having a "Neighbors on Watch (NOW) program. This is a program developed in conjunction with the Colleyville Police Dept. whereby a BLOCK CAPTAIN SYSTEM is maintained to assist residents in crime prevention by helping neighbors know each other and watching for suspicious activities in the immediate neighborhood when someone is known to be away from home. According to NOW reports, substantial decreases in crime and fear result from local crime prevention efforts. Colleyville has a very low crime rate and we want to help keep it that way.

Consequently, we are trying to bolster our Block Captain program to have one person for every 6 homes to be designated as a contact person for the NOW effort. We need many more to volunteer. The duties are minimal and typically lead to good social relationships throughout the neighborhood.




