# **Keep Our Neighborhood Beautiful – Neighborhood Restrictions**

This topic has been discussed many times through e-mails and the newsletter; however, we continue to have several problem areas. Please take time to read the Design Guidelines and Article XII, Use Restrictions in the CCRs you received at closing. If you do not have a copy, they are on the home page of the website, www.shadowglenhoa. com. The "Top Five" violations are:

- YARD MAINTENANCE Need to keeps yards mowed, edged, free of weeds and flower beds maintained. Spring is here and weeds are poppin'!! For week ending 3/11/07 there were 51 yard maintenance violations!
- GARBAGE CANS Need to keep garbage cans out of public view except on pick up day, Wednesday.
- 3. PETS Must keep barking dogs from becoming a nuisance to your neighbors. Must keep cats from roaming freely to use your neighbors flower beds as a litter box. Dogs must be kept on a leash or acceptable restraint whenever outside their home. Pet owners are responsible for picking up their pet's droppings and disposing of them properly. This includes all common areas of ShadowGlen and all yards.
- 4. EXTERIOR HOME IMPROVEMENTS A good rule of thumb is to get prior approval before changing or adding anything to the exterior of your home, yard or fence. This includes, but not limited to, painting, staining, porch additions, patios, patio covers, decks, pools, spas, storage sheds, playscapes, ornamental items such as arbors, statues, fountains, yard art, adding or removing trees or bushes etc, etc... The Architectural Modification Form is also available on the website www.shadowglenhoa.com
- 5. PROHIBITED VEHICLES Commercial vehicles, trailers, campers, recreational vehicles, four wheelers, boats, golf carts, etc, shall be parked only in enclosed garage areas.

You live in a beautiful neighborhood. Please work together to keep ShadowGlen a neighborhood to be proud of.

#### **Pool News to Use**

Many of you have inquired when the pool will open this year. It is scheduled to open weekends beginning May 12th, Saturday 10 AM – 8 PM, Sunday 11 AM – 8 PM. May 25th will mark the beginning of our full time season. Hours: Tuesday – Saturday 10 AM – 8 PM, Sunday 11 AM - 8 PM, closed on Mondays except for Memorial Day, May 28th and Labor Day September 3rd we will be open. The slides will open from 2-7pm.

Last year there was considerable interest expressed in having early morning and nighttime adult lap swim. I was able to get approval for it but I need your help in determining what times are preferred. I currently have it set up for Monday, Wednesday, and Friday mornings, 6 AM – 8 AM; Tuesday and Thursday evenings 8 PM – 10 PM. Lap swimming will begin May 28th. If we do not have enough interest, it will be discontinued or hours will be cut back. If you have any suggestions or preferences on time, please let me know, office@ shadowglenhoa.com or Sheila.walker@goodwintx.com. There will be only one monitor or guard present during lap swimming so no children will be allowed in the pool area during the lap swims.

Another change for this year, the lifeguards will be calling a 10 minute break/adult swim each hour. During this time, only adults over 18 years old may remain in the pool. This gives the lifeguards a quick break, time to test the chemicals, and rotate stands. This eliminates the need for an additional lifeguard just to cover breaks and rotation which would cost an additional \$15,000 - \$18,000 for the pool season.


