Hambledon Homeowners Association, Inc. Board of Directors Meeting – March 8, 2007

The Hambledon Homeowners Association Board of Directors meeting was held at the MUD Administrative Building located at 14003 Walters Rd. Director Sidney called the meeting to order at 6:30 p.m. after they established a quorum with the following present:

Also in attendance were Sgt Hensley and Deputy Simon, Harris County Constables, Robert Alexander, HOA attorney and Kate Loeffler representing VanMor Properties, Inc.

SET AGENDA - The Agenda was accepted.

SECURITY REPORT- Sgt. Hensley and Deputy Simon reported on crime statistics for the month of January 07 and gave the board six crime stopper signs for placement around the Community. Sgt. Hensley noted a task force was in effect for DWI offenses with several police agencies participating.

GUEST/HOMEOWNER FORUM- Mr. Alexander was present to discuss the HOA ability to collect delinquent assessments. He provided the Directors with a handout detailing his cost for services as well as the HOA legal rights in collecting assessments, which included non-judicial foreclosure.

Discussion was held regarding payment plans offered to the delinquent accounts

being handled by the attorney, provided the owner signs an agreement and pays a minimum of 1/3 of their balance due as a down payment. Should an owner, who has not entered a payment plan, issue partial payment, it is the attorney's practice to return the check asking that the full balance owed be submitted. Mr. Alexander explained this action ensures that all legal fees are collected from the owner who incurred the fees and not left to be absorbed by the HOA.

COMMITTEE REPORTS

Website/Newsletter – Director Sanchez reported Peel Inc. would be publishing their first HOA newsletter during the first week of March 07. Contents of the newsletter are to be included on the website.

Yard of the Month – Director Garcia offered to handle the yard of the month program for the year with his wife, Lena's assistance. April winners would be picked during the first week of the month.

APPROVAL OF MINUTES- Upon a motion duly made the Minutes of the February 15, 07 Board Meeting and Executive Session were approved.

MANAGEMENT REPORT- Tabled for discussion during executive session of the Board.

PENDING BUSINESS

MUD 22 Meeting Follow Up

The Board agreed to attend the March 14th Mud 22 Directors meeting in an effort to request shared police patrols whereby the mud facility as well as the residents of Mud 22 could participate and benefit mutually

from such a program.

Briarchase Detention Area Fence

Discussion was held regarding a walk through gate being installed along Briarchase detention area. It was noted Bayou City Remodeling was in the process of completing the improvement, however the Board expressed dissatisfaction with the progress and location to date.

NEW BUSINESS

Landscape Proposals – 42-visit Contract

The Board agreed to invite a representative from Westco Landscapes to the April Board meeting to clarify contractual terms prior to awarding the landscape contract to them. It was agreed to have the property manager ride through the Community with Westco prior to the meeting to ensure all common areas were included in their proposal.

Marquee Repair – Replacement

The Board accepted a proposal from R & R Sign Shop to refurbish the Community marquee at a cost of \$504.24. A bid from Fast Signs to replace the marquee was declined in the amount of \$3,181.00.

NEXT BOARD MEETING- The next meeting scheduled is to be held on Thursday, April 12, 2007 at 6:30 p.m. at the MUD Administration building, 14003 Walters Road.

ADJOURNMENT - There being no further business to discussion the meeting was adjourned at 8:45 pm.

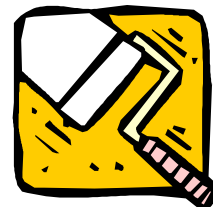

Yard of the Month Kick Off

The summer is approaching fast and that can only mean one thing in Hambledon: It is time to start up the annual "Yard of the Month" project. The Yard of the Month (YOTM) competition runs from April through the end of September.

The purpose of Yard of the Month is to give recognition to homeowners that go "above and beyond" their regular yard maintenance requirements for their front yards. The reward is bragging rights for a month and to proudly display the Yard of the Month sign. We may also publish a picture of your home on the Hambledon-Briarchase website. Most importantly, the competition helps us build and maintain a beautiful community that we can all be proud of.

The Hambledon subdivision is divided into three sections: Hambledon, Hambledon @ Briarchase and Briarchase Estates. One winner will be declared per month in each section.

The YOTM committee uses the following guidelines to judge the yards

1. Consistency Across Yard

Yards should be trimmed, relatively weed free, minimal brown spots, all beds should be neat as visible from street

2. Balance

The yard does not have to have special landscaping, but should have a nice mix of greenery and color. The yard should appear "unique" amongst the neighbors. No professional services are necessary.

3. Seasonal Color

Use of seasonal plants or flowers that add color greatly adds to the uniqueness factor

4. Trash and Storage

Trash cans should be hidden or inconspicuous. Yard should be free of trash and debris

5. Account In Good Standing

All Homeowners fees should be up to date with no outstanding violations.

6. One Award Per Year

A specific address is only eligible for the award once per calendar year.

The Yard of the Month Committee members typically perform a YOTM drive through the first weekend of the month and issue the YOTM signs during the first week of the month. The YOTM homeowners can then display the signs until the following month when the signs are picked up to be distributed to the subsequent month's winner.
