From the WCMA BOD

For the 2007 waste management contract period with Allied/BFI Waste Services recycling was dropped in order to reduce cost to the community due to several reasons. First being that less than 40% of the community was taking advantage of the program. This was based on information provided by Allied Waste Services and other observations made by several Board members over a period of time. Second, there was local convenient recycling available at CFISD schools for paper and St. Max for paper and aluminum where the proceeds go back in to the community. Finally many complaints came in that the vendor had many times put the recycling collection in with the regular trash. As expected, especially with a community as large as ours, (1588 homes), some persons voiced their displeasure at the loss and convenience of curbside pickup. We also heard comments in support of the decision to discontinue the service.

The Board was informed that there was a group that met and took around a petition throughout the community to solicit the support to bring back curbside recycling. This was brought up at our last community meeting where the Board requested a copy be provided to the management company. The Board received the petition during the December frame. Based on wanting to see where the entire community was on the issue without incurring the cost of a special mailing, the Board included a survey with the Annual Assessment bill. As of mid January the Board received 142 responses for bringing back curbside recycling which is 8.9% of the community. We then looked at the number taking in account the petition that was provided which numbered 385 residents or 24.2% for curbside recycling. Combination of the two was 527 or 33.2% in support of curbside recycling.

The following was determined by the Board:

For now, based on the results of the survey and considering the petition as well as taking into account how many residents actually used the recycling service when it was offered, curbside recycling service will not be added to the waste management contract at this time.

Note: The waste management company we are contracted with, WCA, does currently offer recycling and will do so until it is profitable for them. This issue can be revisited at a later date.


