

Common Areas Update

Darlene Page continues to do her usual wonderful support work for our common areas and we thank her for all that she does.

Recently, the Board with help from Select Management did competitive bidding from a number of landscaping companies to ensure we are getting the best value for our maintenance contracts. We are pleased to report that The Lawn Firm was selected to continue as our provider for ongoing grass cutting, shrub trimming and annual color plantings. The Lawn Firm has provided great service for us over the past many years and we are very happy to retain a Colleyville based business.

Additional work in the common areas will be the planting of semi-annual flower color changes. This was a bit delayed this year due to the bidding process, but all our flower beds will be back to their usual beautiful splendor by the time this newsletter is out. The pond in Melrose Park has been treated for algae and the pumps are working well. Debris has been removed from under the city bridge along Martin. The gabions for erosion control have been holding well and improved the most serious of our erosion issues near the bridge.

New sidewalks have been built to replace those most damaged by erosion in our park. You will notice that in the western section of the park, sidewalks have been moved to a location farther away from the creek bed to avoid the issues of damage caused by erosion. There are many more sidewalks that need to be repaired or replaced. However, after much consideration, the WHHOA Board decided that given the current economic situation that we should proceed slowly and carefully with the dues funds that we are entrusted with. Thus, we hope to continue to work towards completion of sidewalk trails in the park, but in a phased approach.


