Summer Resident Writers Program

First Article - Wireless Security

Over the course of three articles, I will discuss a few items for which every home computer user should have at least a basic understanding. Broadband Internet access has revolutionized the way we gather information, shop, and pay our bills. However, that fast, instant access has also opened users up to many types of new threats – threats you may not know exist. These three articles will cover three important aspects of protecting yourself from those that might have malicious intent. In this article, I'll discuss wireless security.

As broadband access has matured, many folks have come to rely on fast, easy and instant access to the Internet. The innovation that has made this access easiest and most convenient for home users is wireless or wi-fi access. Before the advent of wireless, users would have to be connected by a cable to a device that allowed connectivity to the Internet. Wireless allows the user to "ditch the cable" and access the 'net from anywhere a wireless signal is available. Wireless access is especially convenient for homeowners because it negates the need to run network cables, install network jacks, and plug in. In essence, it is the ultimate computing freedom without the hassle of wires and cables.

Wireless does tend to have disadvantages over a wired network connection, though. First, wireless is slower than wired (although wireless speeds will still surpass the maximum speed offered by your broadband connection). Certain devices, such as 2.4 GHz cordless telephones and microwaves, can interfere with some wireless signals – although some of the newer wireless standards overcome this problem. However, the main issue with wireless is security.

Wireless devices use a radio transceiver to transmit data between the networking device and the computer. The problem with this is that many devices come out of the box with no wireless security enabled. In other words, it'll work right out of the box, but transmissions between the access point and your computer are sent "in the clear," meaning that anyone with certain equipment and software can "sniff" your transmissions right out of the air. This means any sensitive information sent over the air could be compromised.

There are some devices – especially the AT&T uVerse devices – that come out of the box with wireless security enabled. Most of the rest of them need to have the feature enabled. These devices will usually come with a CD that is used to set up the device, and if you haven't done the security setup on your wireless access point/router, I suggest you make the time to do it. Besides encrypting and securing

the transmissions between the access point and your computer, the security setup also ensures that your neighbors – or someone driving by – are unable to just grab your wireless signal and start using the broadband Internet connection that you're paying for.

Each manufacturer of wireless routers/access points will have their own procedures to secure the network connection, but they all adhere to a set of standards. I recommend setting up WPA/AES or WPA/TKIP as the encryption/security protocols when you configure your device. Some devices may not present this information to you in an effort to make device setup simple and reduce confusion, but if you see them, choose one of them over WEP security. The main reason is that the password you choose for WPA can be a plain-English password and thus more easy to remember than the password required by WEP.

Finally, for those of you that use free wireless signals in hotels or coffee shops, please beware that those are unsecured wireless networks and that your sensitive data is not safe for transmission. In other words, don't pay bills, shop, or otherwise provide sensitive personal information from an unsecured wireless network.

In short, if you have a wireless network at your home, make sure it is secure. It is a first critical step to ensuring the safety of your electronic data. In next month's article, I'll talk some about Internet security software.

Security Issues in Winchester Trails

The Cy-Fair VFD Urges Citizens to be prepared for **Hurricane Season**

June 1st is the official start of Hurricane season and the Cy-Fair Volunteer Fire Department would like to urge all citizens to make sure they are prepared in the event a hurricane affects them this year. The best way to do this is to have a Disaster Supply Kit ready in advance. This kit should include at a minimum:

- ☐ Water –At least a five to seven day supply (one gallon per person per day)
- ☐ Food –At least a five to seven day supply of nonperishable/
 - (Change out stored water and food supplies every six months)
- ☐ First Aid Kit
- ☐ Flashlight with extra batteries
- ☐ Battery powered radio
- ☐ Medications and special items (pain relievers, diapers, etc.)
- ☐ Tools and supplies
- ☐ Sanitation (toilet paper, personal hygiene items, etc.)
- ☐ Change of clothes and bedding
- □ Cash
- ☐ Important documents (birth certificates, insurance/bank account information, etc.)
- ☐ Food, water, and medicine for your pets
- ☐ Kennels or crates for pets
