TIMELY TIP

for June Gardeners
From Calloway's Nursery

Calloway's Nursery is dedicated to educating young and old alike in being better stewards of our earth. Our weekly Saturday clinics are designed to provide gardening information for adults. Last Summer, we offered several children clinics during the week and had a great response! This Summer we will offer the Callie's Kids Summer Series the first and third Wednesday in June, July, and August at 9:30. Kids will plant, color, learn and explore plants and nature with one of our garden experts. Go here for more details.

Planting a Butterfly garden is fun for all ages. First, choose a location with plenty of sun and protection from strong winds. Add a supply of dark rocks or mass of dark pebbles to collect the morning sun for the butterflies to rest and warm up. Sink a container full of sand or gravel into the ground and keep it moist. This will serve as a resting spot for some to drink and obtain minerals.

Attracting butterflies to your garden is easy. Select foliage plants as food for the larvae or caterpillar, and flowering plants to provide nectar for adults. Butterflies are attracted by fragrance, flower-shape and color. They are mostly active in mid and late summer, so you should make sure that you have lots of nectar-rich plants and flowers blooming by then. If you plant large sections of flowers of the same color, it will make it easier for them to find your garden. You should plant flowers that will bloom at different times of the year and ones that bloom even at different times of the day and night, this way, you will always have something in bloom and they will always be attracting butterflies. Our free clinic on June 12 at 10:15 am will go into more details about planting a Butterfly Garden.








Spotlight On...

THE HOVLAND FAMILY!



Belinda and John Hovland of 2908 Scarborough Ln. W are better known as "that family with all the dogs"! We see them walking a large group of Golden Retrievers at a slow pace like their very own parade around the neighborhood. I've got the scoop on the dogs, but first a bit about the rest of the family. John works for Burlington Northern Santa Fe (BNSF) in a job he loves designing and building intermodal facilities. Belinda is retired from her prior work as an Administrative Assistant. They have two children. John Ross is 25 and lives/works in Ft. Worth. Daughter Lindsey is 21, studying Political Science and History at Trinity University in San Antonio. She has a summer internship job in Washington DC in the Judiciary Committee Office headed by US Representative Lamar Smith of San Antonio. Lindsey hopes to go into politics one day!

The family moved to Texas from Minnesota in 2001. What they like most about living in Woodland Hills is the neighbors and also our mature community with lots of trees. John said the woodsy grounds make Texas seem like "a warm version of Minnesota". The move to Texas was the start of the dog story...

Lindsey insisted that she wouldn't move unless the family got a dog. (ah, the negotiations of a 13 year old – gotta love it!). So the first of many Golden Retrievers arrived from Golden Retriever Rescue of North Texas (GRRNT). Of course, her name was "Goldie". Then that didn't seem like enough, so they added Coco who is still here at a youthful 15 years old. There are currently four dogs at home: Coco, Tex age 15, Harvey age 9 and Ruger age 9. All are older dogs and very sweet and well mannered - but not available for adoption. John says he and Belinda are not the best of Foster Dog Parents because if there is a "vacancy" in the house, they end up keeping the dog! They started with one foster dog in 2003 and generally have 2-4 dogs at home at any one time. Over the years, they have fostered and adopted out at least 7 dogs in addition to filling in for other foster families and other help with maybe a total of 20 dogs overall. Belinda and John "specialize" in older dogs. Older dogs are harder to adopt out - yet they are quiet, house broken and very loving dogs so they make excellent pets.

The Hovlands would like to make sure everyone is aware of the need to rescue pets for adoption. In particular, go to www. goldenretrievers.org to see photos of Golden Retrievers (and Golden look-a-likes and some best friends) available for adoption. Volunteers are needed for intake, transport, foster, and veterinarian services. Our Woodland Hills neighbor Joe Allen helps with his vet services at Boulevard Animal Hospital. John in currently serving as Chairman of the Board of GRRNT organization.

Besides caring for their dogs, the Hovlands like to garden. When asked about something most people don't know about them, there were two answers. They met in school, were engaged within 6 weeks, and have now been married 37 years! Isn't that amazing? Both are also breast cancer survivors – since 1999 for Belinda and 2008 for John. It is a rare disease for men, but be aware that it does happen.

RECYCLING - Most recyclables, when contained properly, can be disposed of at curbside on with either your regular Monday or Thursday garbage service, depending on your location. To report a missed recycling pickup on your street, call 817-503-1119. All containers must be left at curbside no later than 7:00 a.m. on pickup day. Recyclables should not be placed at curbside more than twenty-four (24) hours prior to pick-up day. Additional recycle bins are available to residents at Colleyville City Hall, 100 Main Street. Collections are made on Memorial Day, 4th of July, and Labor Day. If Christmas, New Year's Day, or Thanksgiving fall on a Monday or Thursday, all recyclables will be picked up on the next regularly scheduled pickup day. For more information regarding schedules, routes, and garbage or recycling customer service, please call IESI at 817.222.2221.

DO NOT PUT IN YOUR RECYCLING BIN - Household trash, aluminum foil, auto glass, clothing or bedding, drink boxes and straws, garden hoses, gift wrap and greeting cards, hangers (plastic or metal), hard cover books, light bulbs, medical waste (including syringes, lancets, iv bags and tubing, and medications), paper milk and juice cartons, paper that comes into contact with moist food, including pizza boxes, some frozen food containers, waxed drinking

cups, etc., plastic containers that held hazardous materials such as gasoline, motor oil, paint pesticide or weed killer. Throw empty containers in trash. Plastic bags including grocery sacks, dry cleaners bags, newspaper wrappers, etc., toys, styrofoam (foamed polystyrene) cups, food containers, formed packing, "peanuts," etc., waxed paper and waxed food containers, yard trimmings

HOUSEHOLD HAZARDOUS WASTE - Colleyville residents can dispose of household hazardous waste items (pesticides, paints, chemicals, etc.) at the city of Fort Worth's Environmental Collection Center. Take a recent water bill with you as proof of residency. The ECC is located at 6400 Bridge St. between I-30 and Loop 820. For more information, visit the ECC link on the city's website. Fort Worth charges Colleyville \$47.00 per load, so please offer to also take your neighbors' sealed containers with you. Automotive items such as freon and motor oil can be taken to local automotive stores. Please contact the automotive stores before taking items.

Shut Out From Roth IRAs No Longer



In May 2006, the Tax Increase Prevention and Reconciliation Act (TIPRA) revised some of the guidelines covering IRAs. As a result, high-income investors whose earnings level would previously have restricted them to a Traditional IRA can now convert those to Roth IRAs, effective January 1,

2010, and reap the long-term tax advantages if they will be in the same or a higher tax bracket in retirement.



So if you've maxed out your 401(k) or 403(b) contributions and don't qualify to make Roth IRA contributions because of your income level, you still can make nondeductible contributions to a Traditional IRA (for 2009 through April 15, 2010) in 2010 and then convert them to a Roth IRA in 2010.

At conversion, taxes will not be owed on the original nondeductible contributions although any earnings on those contributions will be taxable. (If the investor owns other Traditional IRAs, those other IRA amounts must be taken into account when performing the calculation to determine the cost basis on Form 8606.) Those who convert in 2010 only, have the extra incentive of being able to spread the taxable income from the conversion over two years- 50% of the income will be taxed in 2011 and 50% will be taxed in 2012 at the rates in effect in those years. Thereafter, all future earnings in the Roth IRA will be available for tax-free distributions if certain requirements discussed below are met.

With a Traditional IRA, account holders are taxed on both their original contributions and their investment earnings when they start withdrawing money. Essentially, the tax responsibility has been deferred, not eliminated. The tax responsibility for a Roth IRA comes at the front end with nondeductible contributions. One of the advantages to account holders, however, is that if certain requirements are met, they do not have to pay any taxes — even on investment earnings — at the time of withdrawal. And that means that Roth IRAs essentially can make investment income tax-free income.

The opportunity to translate nondeductible contributions into additional savings that could result in a tax-free income stream for retirement is especially attractive for high-net-worth individuals who can afford to pay the conversion taxes without using funds from the account itself. By doing so, an investor avoids paying taxes on the distribution of earnings as well as an early distribution penalty of 10 percent if the Roth IRA has been open for at least five years and the investor is at least age 59½. Moreover, because high-net-worth families often have retirement income from other sources, they may not need to tap into their converted Roth IRA for many years, if at all. (Unlike Traditional IRAs, there are no mandatory withdrawal rules for Roth IRAs after the owner attains 70½.) So investors who choose the conversion option can theoretically shelter their earnings until death — an attractive advantage in estate planning.

Here is a simple example of the potential advantage of doing a Roth conversion: A married couple where both spouses are under age 50 can make nondeductible contributions of up to \$10,000 per spouse (\$5,000 for 2009 through April 15th and \$5,000 for 2010) to Traditional IRAs in 2010. That amounts to \$20,000 in additional savings, excluding earnings, in 2010. When the couple converts their Traditional IRAs to Roth IRAs in 2010, the taxable income will, unless elected otherwise by the client, be included in 2 equal installments in tax years 2011 and 2012. All future earnings, however, will accumulate tax-free and all withdrawals from the Roth IRA will be tax-free as well, if the distribution requirements are met (i.e., later than age 59½ and five years after Roth IRA is established). Note: If you already have a traditional IRA with pre-tax dollars (i.e., deductible contributions, rollovers from qualified plans), you should consult your tax advisor about the aggregation rules that will apply if you convert any traditional IRA assets to a Roth IRA.


