## COMPASS CORNER

Hello again neighbors...I have a new subject to discuss with you this month. At the MUD 281 meeting on March 7th there was extensive discussion on water usage in the district. Apparently due to our soil conditions in this area (too much clay) it requires much more water than normal to keep our lawns lush and green. In addition to that, the water requirements for the greenbelts and esplanades are significant as well. You all will remember the near draught conditions we experienced last summer and during that time our water usage was almost double the norm. As such, MUD 281 in conjunction with WDM and our engineering firm, is conducting a study of our water usage history with a breakdown on homeowner use versus common areas usage. When this study is done we will then begin to work on a conservation plan to work out these issues. Worst case scenario would be that the district in conjunction with surrounding MUD's would have to construct an additional water plant to supply our needs...a very expensive solution both in initial construction

A majority of people overestimate their own and their child's ability to swim, especially in a panic event.

DROWNING IS QUICK AND SILENT



Drowning occurs in as little as 2 minutes.



Irreversible brain damage occurs in as little as 4 minutes.



Most children are out of sight or missing for less than 5 minutes and usually in the presence of 1 or both parents.



Most children die who are submerged for as little as 6-10 minutes.

Children who drown do not scream, splash, or struggle. They silently slip beneath the water, even with adults & lifeguards present.


### Tomball Garden Club Annual Plant Sale
