

- Motion Sensor Lights outside where windows & doors could be accessed.
- Motion Sensor sirens inside that can be set like an alarm when you leave - or simply plugged in to any outlet.

Not so basic – but very effective items you should consider:

- Home alarm system monitored or not to set off a siren. There are some very cheap wireless alarm systems you can install yourself now. They are very easy.
- Garage Door Openers that close by themselves if you leave them open. Sears has them and I use them – they are very cool because I always forget to close my garage.


